Abstract (en)

A cartridge (60) for storing liquefied gas under pressure comprises a container (67) and a valve (30). The valve (30) has a jacket (31) fitted to the container (67), which encloses a hollow body (34) with an inlet (39) and an outlet. The hollow body (34) has in its interior a movable element (35) moving between a position that allows the flow of the gas outwards from the cartridge (60) and a position that does not. The hollow body (34) has one end that is within the container (67) and sealed with a bottom (38) that does not allow the flow of the gas from the said end towards the interior of the hollow body (34). The bottom (38) does not allow the flow of gas either in liquid or gaseous form within the hollow body and ensures a flawless flow of the fluid without causing clogging of the valve.
