Abstract (en)

In the roof window arrangement, a plurality of window units (21, 22, 23) are arranged in a side-by-side configuration and a covering assembly (5) is provided. At least one covering (512, 513) associated to one window unit (22, 21, 23) is configured to function as a covering of that one window unit (22, 21, 23) and of a neighbouring window unit (21, 23, 22).
