Abstract (en)  
[origin: EP3832013A1] Provided is rolling paper for a non-combusted heated smoking article that has a white section in which the discrimination score obtained by substituting color difference values in the CIE Lab color system before and after heating for three minutes at 230°C in equation (1) is a numerical value lower than 0.62 and ISO whiteness is at least 83%. (1) Discrimination score (y)  $y = -0.18 \times \Delta L^* + 0.08 \times \Delta a^* + 0.13 \times \Delta b^* - 2.36$  (In equation (1), the color difference values in the CIE Lab color system before and after heating are the values for  $L^*$ ,  $a^*$ , and  $b^*$  before heating subtracted from the values for  $L^*$ ,  $a^*$ , and  $b^*$  after heating.  $\Delta L^*$  represents the difference in lightness  $L^*$  after heating and before heating the rolling paper.  $\Delta a^*$  represents the difference in color  $a^*$  after heating and before heating the rolling paper.  $\Delta b^*$  represents the difference in color  $b^*$  after heating and before heating the rolling paper.)
