Abstract (en)

[origin: WO2020030800A1] The invention relates to processing device for processing a fluid, in particular with the aid of a mechanical separation. The processing device has a processing medium, which has a round granulate. Furthermore, the processing device has two walls, wherein flat sides of the walls are opposite one another. The fluid flows through the processing medium. At least one of the two walls is fluid-permeable such that the fluid enters the processing medium or exits the processing medium through the fluid-permeable wall. The processing device is designed to transport at least a part of the processing medium, along the walls and thus through the flow region.
