[origin: WO2020033983A1] The invention relates to a method for producing a cast part from metal and to a casting machine (1) for a metal casting, comprising at least one mould (2), having mould impression parts (4, 5, 6, 7), defining a cavity (3), characterized in that each mould impression part (4, 5, 6, 7) of at least a first subset of the mould impression parts (4, 5, 6, 7) is mounted pivotably about at least one first axis of rotation (a, b, c, d) of its own, wherein the entire mould together with all of the mould impression parts is mounted about at least one second axis of rotation (e).
