Abstract (en)

The present teachings are directed to inorganic oxide materials that include Al₂O₃, CeO₂, and at least one of MgO and Pr₆O₁₁. The present teachings are also directed to catalysts having at least one noble metal supported on these inorganic oxide materials, as well as methods for treating exhaust gases from internal combustion engines using such catalysts.
