Abstract (en)
[origin: WO2020039063A1] This prosthesis or orthosis for a joint, such as an ankle, comprises a first body (20), a second body (30), and an articulated joint (4) between the first and second bodies, the articulated joint (4) allowing the rotation of the first and second bodies with respect to one another around a joint rotation axis (10). It further comprises a locking mechanism (5) configured to selectively lock the rotation between the first and second bodies in one direction, when it is in a locked configuration, and a transmission mechanism (8, 12) such that a rotation of the joint rotation axis (10) generates a movement of a lockable part (7, 5) of the locking mechanism (5). The axis (15) of the movement of the lockable part (7, 5) is shifted relative to the joint rotation axis (10) and the transmission mechanism (8, 2) comprises a reducer configured to reduce effort to lock the rotation of the first body with respect to the second body.
