Abstract (en)

[origin: WO2020052898A1] The invention relates to a single-use deformable capsule comprising: a pouch (11, 41): containing a cosmetic product, of which the periphery (16, 46) is formed by two sheets (2 and 3, 5 and 6) pressed firmly together and joined to one another, a canal (20, 50): connecting the pouch (11, 41) to the outside of the capsule (1, 4), forming a narrowing of cross-section relative to the pouch (1, 4), a frangible wall (13, 43): separating the pouch (11, 41) from the canal (20, 50), having the form of a salient angular sector (13, 43) projecting into the otherwise convex shape of the periphery (16, 46) of the pouch (11, 41), of which the breakage, brought about by pressure applied to the pouch (11, 41), comes about by the peeling-apart, at this salient angular sector (13, 43), of these two sheets (2 and 3, 5 and 6) which are pressed firmly together and joined to one another, places the pouch (11, 41) in communication with the canal (20, 50) so that the cosmetic product flows from the pouch (11, 41) towards the canal (20, 50), a connector (14, 44): male (44) or female (14), intended to couple with a connector, female (14) or male (44), of another capsule (1, 4), rigid enough to provide a fluidtight connection between the capsules (1, 4), once the connectors (14, 44) have been coupled to one another, situated at an opposite end (52) of the canal (50) to an end (51) of the canal (50) that is situated at the pouch (41) end, or else situated at an opening (22) of the canal (20) that is distinct from that end (21) of the canal (2) that is situated at the pouch (11) end, opening to the outside of the capsule (1).
