Abstract (en)
[origin: EP3855089A1] An air conditioner of the embodiment includes one or a plurality of indoor units, one or a plurality of outdoor units, a thermo-off detector, and a controller. The one or plurality of indoor units include an indoor expansion valve and an indoor blower. The one or plurality of outdoor units include a compressor. The thermo-off detector detects the thermo-off of the one or plurality of indoor units at the time of the heating operation. The controller controls an operation of the compressor and an operation of an indoor expansion valve or an indoor blower of the one or plurality of indoor units, on the basis of a result of the detection of the thermo-off, when there is an indoor unit which does not performing the heating operation, among the one or plurality of indoor units.
