Abstract (en)  
A display support made of paper material for packaged products is described, the display support comprising a rear portion (200, 500) provided a back wall, side walls and a top panel (220, 520, 820, 920), the top panel (220, 520, 820, 920) having at least one opening which together with the back and side walls of the rear portion (200;500) defines at least one recess (221, 521, 821, 921) for housing a packaged product, a front panel (300, 600, 820, 920) having an opening (321, 621, 821, 921) at the at least one recess (221, 521, 821, 921), and at least one flap (381, 681, 882, 981) extended from said opening on the front panel inwards of said at least one recess, characterized in that the rear portion (200, 500) has a plurality of recesses (221, 222; 521, 522) having respective base panels (240, 261; 530, 561) at different distances from the front panel (300, 600).
