Abstract (en)

A package (1000) comprising a bag (100) and a stack of absorbent articles (200) having a substantially rectangular shape, wherein the stack of absorbent articles is arranged in the bag. The bag (100) is made of a paper material having a basis weight between 60 and 100 g/m² measured according to the ISO 536 standard, wherein the bag (100) has a closed bottom (110), a closed top (120), and a peripheral wall (130) between said bottom and said top. The bag is provided at least on an inner surface of the bag near the top, with a sealable coating (140) wherein the closed top (120) is realized by a sealed portion (145) of said sealable coating (140).
