Abstract (en)

[origin: CA3114659A1] The invention relates to a method for controlling a wind farm operated by means of a wind farm control unit, which wind farm comprises a plurality of wind turbines having wind turbine controllers, which wind turbines are connected to one another by means of a common wind farm grid, which is connected to an electrical supply grid of a grid operator by means of a wind farm transformer, comprising the steps: receiving at least one fault bit at the wind farm control unit, in particular at least one fault bit of the network operator; deactivating all external setpoint-value specifications at the wind farm control unit, except for those of the network operator, after the receipt of the fault bit; activating fault control implemented in the wind farm control unit after all external setpoint-value specifications except for those of the network operator have been successfully deactivated.
