[origin: WO2020084159A1] The present invention relates to a device (60) for manufacturing pharmaceutical compositions, comprising: a support (62); a mixing container (16); a plurality of reservoirs (18, 20) containing starting materials used in the composition of a drug; at least one dispensing device (64, 66) capable of dispensing a quantity of a starting product in the mixing container, the dispensing device being attached or capable of being attached to a reservoir; a stirring device (68) capable of stirring the mixing container and/or a content of the mixing container; and an electronic module (74) for controlling the at least one dispensing device.
