[origin: WO2020094191A1] The invention relates to an endoscopic instrument (1, 134) for inserting into a body of a patient, wherein the instrument (1,134) has a tubular, flexible shaft (3, 47, 137) having a first working channel (15) and a second working channel (19, 131), wherein a shaft tool can be guided through the first working channel (15) and a light guide (123) can be guided through the second working channel (19, 131), wherein the cross section of the first working channel (15) is at least twice as large as the cross section of the second working channel (19, 131).
