Abstract (en)

[origin: WO2020108511A1] A lighting and/or signal apparatus and a vehicle. The optical assembly (10) comprises a heat dissipating module (20), a light emitting module (30) and a reflecting module (40), the light emitting module (30) having a light source (31) and being arranged on the heat dissipating module (20), with at least a part of light emitted by the light source (31) reaching a reflecting surface of the reflecting module (40), wherein a connecting plate (45) is disposed on a side of the reflecting module (40) which is opposite to the reflecting surface, the connecting plate has a slot (46), the heat dissipating module (20) correspondingly has a pivot (26) accommodated in the slot (46), and the reflecting module (40) is positionally fixed and connected to the heat dissipating module (20).
