Abstract (en)

[origin: WO2020120204A2] The present invention relates to a method for controlling a phytopatogenic fungi selected from Septoria tritici and Puccinia spp. on cereals, comprising treating the plants, their seed or the soil with a fungicidally effective amount of the composition comprising mefenitrifluconazole and a further active compound (II) selected from benzovindiflupyr, boscalid, dimoxystrobin, fenpicoxamid, fenpropimorph, florylpicoxamid, fluindapyr, fluxapyroxad, ipyrfluxam, ipfufenoquin, isoflucypram, isofetamid, kresoxym-methyl, quinofumelin, picarbutrazox, pydiflumetofen, pyraclostrobin, pyrapropoyne, 1-(4,5-dimethylbenzimidazol-1-yl)-4,4,6-trifluoro-3,3-dimethyl- isoquinoline, 6-chloro-1-(4,5-dimethylbenzimidazol-1-yl)-4,4-difluoro-3,3-dimethyl-isoquinoline, -(4,5-dimethylbenzimidazol-1-yl)-4,4-difluoro-3,3-dimethyl-isoquinoline, 4,4-difluoro-3,3-dimethyl-1-(4-methylbenzimidazol-1-yl)isoquinoline, 1-(6-chloro-7-methyl-pyrazolo[1,5-a]pyridin-3-yl)-4,4-difluoro-3,3-dimethyl-isoquinoline, 4,4-difluoro-1-(6-fluoro-7-methyl-pyrazolo[1,5-a]pyridin-3-yl)-3,3-dimethyl-isoquinoline, 4,4-difluoro-3,3-dimethyl-1-(6-methylpyrazolo[1,5-a]pyridin-3-yl)isoquinoline, 1-(6,7-dimethylpyrazolo[1,5-a]pyridin-3-yl)-4,4-difluoro-3,3-dimethyl- isoquinoline and 1-(7,8-dimethylimidazo[1,2-a]pyridin-3-yl)-4,4-difluoro-3,3-dimethyl-isoquinoline.
