Abstract (en)
[origin: WO2020127911A1] The present invention concerns a mixing machine (6) comprising - a support (31) defining a receiving cavity (32), the receiving cavity (32) comprising a first receiving location (13) configured to receive a first deformable capsule (3) and a second receiving location (14), configured to receive a second deformable capsule (4), the first and second capsules (3,4) being intended to be fluidically connected to each other and respectively containing a first formulation and a second formulation, - an actuation system (35) that is movable relative to the support (31) along a nominal travel path (C35), inside the receiving cavity (32), in which the actuation system (35) comprises a spring (37.4, 38.4) capable of being compressed when the actuation system (35) reaches the end of the nominal travel path (C35).
