Abstract (en)  
The invention discloses a kind of multifunctional fitness shoes which can be worn on the feet and relate to the technical field of sports fitness equipment. The multifunctional fitness shoes that can be worn on the feet include the body of the fitness shoes and the elastic bands disposed on the body. The aforesaid fitness shoes can be worn on the feet and the body of the fitness shoes is disposed with adjustable elastic bands, and more than one snap ring is arranged around the body of the aforesaid fitness shoes. Both ends of the elastic bands are respectively disposed with a buckle, and one end of the elastic band is connected with the snap ring on the body of the aforesaid fitness shoes through the buckle.
