[origin: EP3913079A1] A non-oriented electrical steel sheet has a chemical composition containing, in terms of % by mass, C: 0.0015% or less and Si: 2.5 to 4.0% and having an average crystal grain size of 10 to 40 µm, and an internal oxidation layer having a thickness of 0.5 to 3.0 µm present in a sheet thickness direction of a surface thereof.
