Abstract (en)

[origin: EP3940103A1] Disclosed is a thick steel plate with the composition satisfying predetermined C, Si, Mn, P, S, Al, Nb, Ti, N and Ca, with the balance consisting of Fe and inevitable impurities, the composition satisfying  $Di + 10Nb: 1.20$  to  $2.50$  determined from the equation (1) below, wherein a total area fraction SA of crystal grains having an equivalent circle diameter of  $7.5 \mu\text{m}$  or less, among crystal grains surrounded by high-angle grain boundaries having a crystal misorientation of  $15^\circ$  or more, is  $34\%$  or more at the  $1/4$  position of the plate thickness, and  $27\%$  or more at the  $1/2$  position of the plate thickness:  $Di = 1.16 \times C / 100.5 \times 0.7 \times Si + 1 \times 5.1 \times Mn - 1.2 + 5 \times 0.35 \times Cu + 1 \times 0.36 \times Ni + 1 \times 2.16 \times Cr + 1 \times 3 \times Mo + 1 \times 1.75 \times V + 1 \times 200 \times B + 1$  where, in the equation (1), [element] indicates the content of each element expressed in % by mass, and the content of an element not included is zero.
