[origin: WO2020187728A1] The present invention relates to a method for dyeing keratinous material, in particular human hair, comprising the following steps: - applying an agent (a) to the keratinous material, said agent (a) containing: (a1) at least one organic silicon compound from the group comprising silanes, said compound having one, two or three silicon atoms; and (a2) at least one first chromophoric compound comprising at least one pigment based on a lenticular substrate plate, and - applying an agent (b) to the keratinous material, said agent (b) containing: (b1) at least one film-forming polymer and (b2) at least one second chromophoric compound from the group of pigments and/or the direct dyes.
