Abstract (en)

An exercise bag (100) is configured to carry a belt, such as a weightlifting belt, along with other personal items. The belt may be carried by a retainer element (150) on an external portion of the exercise bag. The exercise bag may have any number of compartments, pouches, and/or other retainers or holders. The belt, when carried on the exercise bag may be accessible without having to open or otherwise access any other compartment or pouch of the exercise bag. Additionally, the compartments and/or pouches of the exercise bag may be accessible without having to remove or loosen the belt held by the retainer on the exercise bag. The exercise bag may further have a shoe compartment that is directly accessible from the outside of the exercise bag, with a liner that keeps shoes separate from other items in the exercise bag.
