Abstract (en)

A securing device 1 has a coupling ring 3 which must be fixedly attached to or in the deck of the vessel and a coupling sleeve 5 which must be fixedly attached to the underside of a vessel's mast. The coupling ring 3 is provided on the inner side 3A and the coupling sleeve 5 is provided on the outer side 5B with projections 7 and/or recesses 9 which together form a bayonet coupling. A blocking device 11 ensures that the coupling ring 3 and the coupling sleeve 5 cannot rotate relative to each other. This blocking device 11 has a blocking element 13 which is attached to the coupling ring 3 and a blocking body 15 which is slidable in the axial direction in the coupling sleeve 5 between an upper, release position and a lower, blocking position. In the blocking position, the blocking body 15 cooperates with the blocking element 13 such that the blocking body 15 cannot rotate relative to the blocking element 13.
