Abstract (en)

[origin: WO2020212160A1] The invention relates to a packet for products of the cigarette industry, comprising: - a tray (13) made of a preferably stiff packaging material, in particular paperboard, for holding a group of products as packet contents (12); and - a wrapping (14), which is made of a packaging material surrounding the packet contents (12) and the tray (13) preferably on all sides, the wrapping (14) being formed by folding a blank (15) of the packaging material, and folding flaps of the blank (15) being connected to one another by sealing. The invention is characterized in that a seal (44) is formed in the region of at least one edge of the tray (13) and in that the seal (44) of the folding flaps (31, 32) to be connected is formed against at least one edge of the tray (13) by applying a sealing pressure, by means of a sealing element (45), to the folding flaps (31, 32) to be sealed, which are overlappingly arranged, the sealing pressure being exerted on the folding flaps (31, 32) substantially in the plane of a wall of the tray (13) such that the sealing element (45) seals the folding flaps (31, 32) to be connected against the edge or each corresponding edge of the tray (13). The invention also relates to a method and a device for producing packets of this type.
