[origin: WO2021118186A2] The present disclosure relates to an aerosol-generating article including a first portion including an aerosol-generating material; a second portion including a tobacco material in a form of a tobacco sheet; a third portion configured to cool airflow which has passed through the first portion and the second portion; and a fourth portion including a filter material, wherein the first portion, the second portion, the third portion, and the fourth portion are sequentially arranged in a length direction of the aerosol-generating article.
