[origin: WO2020239891A1] The present invention relates to a steel strip, sheet or blank for producing hot-stamped parts having the following composition in wt%: C: < 0.20, Mn: 0.65 - 3.0,5 W: 0.10 - 0.60, and optionally one or more of the elements selected from: Si: < 0.10, Mo: ≤ 0.10, Al: ≤ 0.10,10 Cr: ≤ 0.10, Cu: ≤ 0.10, N: ≤ 0.010, P: ≤ 0.030, S: ≤ 0.025,15 O: ≤ 0.01, Ti: ≤ 0.02, V: ≤ 0.15, Nb: ≤ 0.01, B: ≤ 0.0005,20 the remainder being iron and unavoidable impurities.
