[origin: WO2020254048A1] A first computer-implemented method for managing a textile machine has the steps of allowing an object that represents the textile machine to be generated, selected, and/or removed and allowing replacement and/or wear parts belonging to the textile machine to be added to the representative object and/or to be changed and/or removed. A computer-implemented method for managing a textile system has the steps of allowing a textile system comprising multiple textile machines to be generated, changed, and/or deleted and allowing each of the textile machines to be managed according to the first method. A computer-implemented method for managing an assembly comprising multiple textile systems comprises the step of allowing a combination of multiple textile systems to be generated, changed, and/or deleted and each of the textile systems to be managed according to the second method. A computer-readable medium comprises commands which can be carried out by a processor in order to allow such a processor to carry out one of the aforementioned methods. A device comprises a processor, which is designed to carry out one of the aforementioned methods, and an interaction device, which is designed to interact with a user with respect to the method steps by means of the processor.
