[origin: WO2021001722A1] The invention relates to a balance wheel-hairspring oscillator (10) comprising: a balance wheel shaft (18) intended to be pivotably mounted on a frame of a timepiece; a balance wheel (12) secured to the balance wheel shaft (18); a hairspring (14) comprising an inner end (14a) secured to the balance wheel shaft and an outer end (14b) intended to be connected to a connecting member (16) to said frame, and a transmission member (20, 22) arranged to interact with an escapement. The balance wheel (12) and the hairspring (16) are arranged on either side of the transmission member.
