[origin: CN114563939A] The invention relates to a fixing device (100) for adjusting the clearance of a balance wheel (200). The at least one fixing device (100) comprises at least one pin holder (110), at least one bearing body (120), at least one support member (130) and at least one retaining member (140). The at least one bearing body (120) is configured to move relative to the at least one pin holder (110) in order to fix the adjustment of the clearance of the balance wheel (200), and the at least one support member (130) is configured to press the at least one bearing body (120) against the at least one pin holder (110) prior to being held by the at least one holding member (140).

Ledit au moins un corps de palier (120) est configuré pour se déplacer par rapport audit au moins un porte-piton (110) de sorte à fixer le réglage dudit ébat dudit balancier (200) et ledit au moins un organe d'appui (130) est configuré pour appuyer ledit au moins un corps de palier (120) contre ledit au moins un porte-piton (110) avant d'être maintenu par ledit au moins un organe de maintien (140).
