Abstract (en)
The present invention relates to a solid laundry detergent composition, more specifically to laundry detergent composition comprising low levels of alkaline builders. It is an object of the present invention to provide a solid laundry detergent composition having low carbonate levels and low silicate levels which gives good solubility profile, good cleaning profile, good stability profile, good fabric care profile and good freshness profile. The present inventors have surprisingly found that the fabric care benefits and stain removal performance of solid laundry detergent composition having low carbonate levels and low silicate levels can be achieved by combination of an anionic surfactant with amphoteric surfactant and a silicone surfactant.
