Abstract (en)
Examples include a consumer product comprising a detergent product and a container comprising a box, a cover and a lock to maintain the cover in a closed position. The lock comprises at least a first actuator moveable from a locking position to an opening position by applying an actuation pressure onto the first actuator when the cover is in the closed position. The cover comprises a first tactile discontinuity, the first tactile discontinuity facing the first actuator, the first tactile discontinuity permitting displacing the first actuator from the locking position to the opening position by applying the actuation pressure at the first tactile discontinuity when the cover is in the closed position, whereby the cover further comprise a second tactile discontinuity, the second tactile discontinuity directly facing the second specific portion of sidewalls when the cover is in the closed position.
