Abstract (en)

[origin: EP4043219A1] A liquid discharge device (100) for discharging and applying liquid to a target discharging medium (2) conveyed in a predetermined conveying direction (20) to form a discharged region, includes a plurality of liquid discharge units (30, 30a, 30b, 30c, 30d) configured to discharge the liquid based on a drive waveform (33, 34); an output unit (74) configured to output the drive waveform to the liquid discharge unit; an acquisition unit (71) configured to acquire information representing a characteristic of the liquid; and a switching unit (75) configured to switch the drive waveform based on the characteristic. The plurality of liquid discharge units includes first and second liquid discharge units (30a, 30b), disposed at position separated from each other in the conveying direction. When the characteristic satisfies a predetermined condition, positions at which the liquid is applied by the first and second liquid discharge units on the target discharging medium are separated from each other in the conveying direction.
