Abstract (en)

[origin: WO2021084502A1] The invention relates to a stimulator substrate device (15) for stimulating nerve cells, in particular nerve cells in an extremity, comprising a substrate support (20; 20a;), in which a plurality of stimulators (21, 22, 23, 24) for emitting stimulation signals to the nerve cells are provided. The plurality of stimulators (21, 22, 23, 24) is provided in a line on the substrate support (20; 20a;) and said substrate support (20; 20a;) is tubular. The invention also relates to a device for stimulating nerve cells, comprising a stimulator substrate device (15; 15a; 15b).
