Abstract (en)  
[origin: CA3156770A1] The invention relates to a water sport device, in particular a foilboard, comprising a floating body (4), preferably in the form of a floating board, and at least one foil device (6) which is secured to the floating body (4) by means of a retaining device (8) having at least one first link (10), wherein the foil device (6) has at least one, preferably at least two foils (16), and it can be transferred via the retaining device (8) into an operating position below the floating body (4), wherein, in the operating position and during a forward movement, due to an uplift force caused by the foil device (6), the floating body (4) can be transferred into a position in which is spaced apart from the surface of the water, wherein the foil device (6) can be transferred, in particular extended and retracted and/or folded, from an idle and/or starting position into the operating position and/or from the operating position into the idle and/or starting position via the retaining device (8), and the water sport device, preferably the retaining device has, in particular, a drive (12) provided with an energy accumulator for this purpose.
