The invention relates to a selection device (200, 200 ') comprising a frame (100, 100'), an interface element (1), in particular a control handle (1), and setting lever means (150, 150 ') arranged to define n stable positions of the interface element (1) and m selection configurations of the selection device (200, 200'), where  $n \geq 3$ ,  $m \geq n + 1$ .
