Abstract (en)

[origin: WO2021116552A1] Disclosed is a folding child seat (1) for attachment to a chair (24), a pushchair (46) or a trolley case (20), comprising: - a first portion (2A) intended to be in contact with the child's back, a second portion (2B) intended to constitute a seat portion of the seat (1) and a third portion (2C) intended to be in contact with the child's feet, - the first portion (2A) comprises an attachment by rings (26, 27, 28, 36) in the vicinity of a first edge and an attachment on an edge opposite a first edge of the second portion (2B) also by rings (26, 27, 28, 36), the second portion (2B) comprising an attachment on an edge opposite the first edge to a first edge of the third portion (2C), an attachment strap (3, 42) provided with buckling elements at its ends joining the opposing rings (26, 27, 28, 36), - the seat (1) being able to switch from an unfolded position to a folded position, by folding the third portion (2C) into contact with the second portion (2B), and the assembly formed by the second portion (2B) and the third portion (2C) then being folded into contact with the first portion (2A), this assembly cooperates at the attachment rings (26, 28, 30, 31, 34, 36), with the attachment strap (3, 42) via the buckling elements (38, 39, 4, 55), - the seat (1) being further provided with other attachment straps (3, 40), the modularity of the attachment straps (3, 40) allowing the seat (1) to acquire a baby carrier function, as required, the set of attachment straps (3, 40) allowing at least three attachment points (11, 16, 26) to be formed on the chair (24), the pushchair (46) or the trolley case (20), - the seat (1) also being provided with a harness for holding the child in the seat (1), and side safety straps (3, 40, 46A, 54).
