Abstract (en)
[origin: WO2021119689A1] The invention relates to a guide device (4), for guiding a furniture part (2), in particular a sliding door or a folding sliding door, on a guide rail (16, 17), comprising at least one rolling carriage (18) having at least one rotatably mounted rolling body (19, 20), via which the at least one rolling carriage (18) can be moveably mounted on a track (21, 22, 23) of the guide rail (16, 17), and at least one connection device (1), in particular designed as a hinge, for connecting the guide device (4) to the furniture part (2), wherein the at least one rolling carriage (18) and the at least one connection device (1) are designed as separate components and can be connected to one another, in particular detachably, via at least one securing device (24), wherein the at least one securing device (24) has at least one locking element (25) which is mounted on the at least one connection device (1) or on the at least one rolling carriage (18) such that it can rotate and move, preferably transverse to a securing direction (26) of the at least one connection device (1) and the at least one rolling carriage (18).
