[origin: WO2021150638A1] Compositions and methods for improving gastrointestinal function and reducing the presence of gas bubbles in a gastrointestinal tract. A method for increasing visibility of a gastrointestinal tract of a user during an endoscopy procedure comprises flushing at least a portion of the gastrointestinal tract of the user with a composition during the endoscopy procedure. The composition includes an effective amount of ginger root extract for reducing a presence of gas bubbles in the gastrointestinal tract of the user, propylene glycol, and sodium chloride.
