[origin: WO2021148366A1] The invention relates to a composition in a form suitable for topical administration comprising, in a cosmetically and/or pharmaceutically acceptable carrier, at least one Urtica extract. The invention is characterized in that it further comprises a mixture of at least five plant extracts. The invention further relates to a method for producing such a composition. Such a composition is particularly useful for the prevention, treatment, relief and calming of symptoms of hemorrhoidal illness and as an aide for healing wounds and calming burns.
