Abstract (en)

The invention relates to a method of damping vibrations of a yarn winding device (5) for winding yarn on a bobbin (6) of a textile machine in which vibrations are damped by the action of magnetic force between a permanent magnet (14) on a winding arm (8) and a magnetically adhesive body (11) assigned to the winding arm (8), whereby the permanent magnet (14) moves on the magnetically adhesive body (11). During its movement on the magnetically adhesive body (11) relative to the winding arm (8), the permanent magnet (14) moves with an additional movement with two degrees of freedom relative to the tilting plane of the winding arms (8), thus selfadjusting relative to the magnetically adhesive body (11).The invention also relates to a device for performing the method and to a textile machine with this device.
