Abstract (en)

[origin: EP4104912A1] A board-typed card battle game apparatus in accordance with an exemplary embodiment includes a game board divided into two sides competing against each other and provided to include, for each side, a plurality of battle lines, and a battle cell, a deck cell, an ambush cell, and a grave cell that are independently partitioned, and game cards provided to include a first card disposed on the battle cell and printed with characteristic information, a plurality of second cards selected from the deck cell, disposed adjacent to the first card, and printed with the characteristic information, a plurality of third cards selected from the deck cell and printed with the characteristic information, a fourth card selected from the deck cell, disposed in the ambush cell, and printed with the characteristic information, a fifth card given to a first side, disposed adjacent to the first card, and printed with the characteristic information, and a sixth card given to a second side competing against the first side and printed with the characteristic information, in which the first to third cards are used to attack an opponent side, and a win is gained when a defense power in the characteristic information of the first card of the opponent side reaches zero.
