[origin: WO2021173018A1] The invention relates to a process for the production of reactive polyols from wood-like waste materials on the fact that the wood-like waste material is used as a wood-like material, which is chipped to a grain size of 1 to 500 pm, and this material is subjected to a solvolysis process in the presence of a solvent or mixture of solvents with the amount of biomass from 1-50% of the weight of the solvent with the catalyst at the temperature from 80 to 300 ° C and the obtained polyol raw material is neutralized with an acid or a base.
