[origin: WO2023001740A1] The invention relates to a device that is to be worn on the back, comprising a carrying strap unit and a rechargeable battery pack receptacle that is attached thereto for receiving a rechargeable battery pack for supplying energy to a hand-held electric apparatus, wherein the carrying strap unit has a strap adjustment device, by which a shoulder strap of the carrying strap unit can be adjusted such that the rechargeable battery pack receptacle can be brought from a position on the back to a position at the hip, the shoulder strap remaining at least in some sections on a shoulder of the user for dissipating the load.
