Abstract (en)

An optical fiber includes a core, an inner cladding surrounding the core, and an outer cladding surrounding the inner cladding. A mean relative refractive index difference  $\Delta_1$  of the core with respect to pure silica, a mean relative refractive index difference  $\Delta_2$  of the inner cladding with respect to pure silica, and a mean relative refractive index difference  $\Delta_3$  of the outer cladding with respect to pure silica satisfy a relationship of  $\Delta_1 > \Delta_3 \geq \Delta_2$ . A ratio  $r_2/r_1$  of an inner cladding radius  $r_2$  to a core radius  $r_1$  is 4.5 or higher and 5.5 or lower. A minimum value  $\Delta_{min}$  of a relative refractive index difference with respect to pure silica is -0.030% or higher and -0.010% or lower. A radius  $r_{min}$  at which the relative refractive index difference is the minimum value  $\Delta_{min}$  satisfies a relationship of  $r_1 < r_{min} < r_2$ .  $(\Delta_{min}-\Delta(r_1))/(r_{min}-r_1)$  is -0.002%/ $\mu m$  or lower, where  $\Delta(r_1)$  denotes the relative refractive index difference with the core radius  $r_1$ .
