Abstract (en)

[origin: WO2021212159A1] The invention relates to a furniture drive (1) for moving a furniture part (3) that is mounted movably relative to a furniture body (2), in particular for moving a furniture flap that is pivotable about a horizontal axis relative to the furniture body (2), comprising: - a housing (4) which can be located on or in a furniture panel (5) of the furniture body (2), - at least one actuating arm (6) which is mounted movably relative to the housing (4) and on which the movable furniture part (3) can be fastened, wherein the housing (4) has an end face (7) through which the at least one actuating arm (6) protrudes in at least one relative position (8), - at least one spring device (9) by means of which a force can be exerted onto the at least one actuating arm (6), - at least one adjusting device (10) for adjusting the force that can be exerted onto the at least one actuating arm (6) by the at least one spring device (9), and - at least one display device (11) by means of which a force adjustment that can be carried out by the at least one adjusting device (10) can be displayed, wherein the at least one display device (11) is formed separately from the at least one adjusting device (10) and can be read in an installed position (12) of the furniture drive (1), in which position the housing (4) is located completely, except for the end face (7), in the furniture panel (5) of the furniture body (2).
