Abstract (en)

A method for controlling the machining of panels with a substantially parallelepiped-like shape is described and a machine (1) for machining panels with a substantially parallelepiped-like shape comprising a processing system (17) having a control unit (18), a thickness detection device (22) for detecting the thickness of the panels (2), which is obtained by means of a digital caliper (24) with a slider, a support (23) for the thickness detection device (22), a wireless data communication system provided with two Bluetooth communication modules (29, 30) housed in the thickness detection device (22) and in the control unit (18), respectively, and a presence sensor (33) housed on the support (23) to detect the presence of the detection device (22).
