Abstract (en)

Method for moisturizing a pouched product (103, 203) for oral use, comprising the steps of: a) providing a plurality of pouched products (103, 203) for oral use, the pouched products (103, 203) having a first moisture content; b) laying down the pouched products (103, 203) on a support surface (111, 211); and c) applying water with a water application tool (105, 205) comprising a water dispensing arrangement (117, 217) to the pouched products (103, 203) in a confined water application area (106, 206) of the support surface (111, 211), to raise the moisture content to a second moisture content, the second moisture content being higher than the first moisture content.
