Abstract (en)

[origin: US2022393127A1] An organic light-emitting diode display device is provided by the present application, including an anode layer, a cathode layer, and a light-emitting layer disposed between the anode layer and the cathode layer, wherein the light-emitting layer includes a first light-emitting layer and a second light-emitting layer stacked. The first light-emitting layer includes a first color light-emitting part, a second color light-emitting part, and a third color light-emitting part arranged in a same layer. The second light-emitting layer is configured to emit light of a first color, and the second light-emitting layer is disposed at a side of the first light-emitting layer and covers the first light-emitting layer.
