[origin: CA3181105A1] The invention relates to an apparatus (21) for producing a dried product (25) suitable as a fertiliser and/or fodder, comprising a chamber (16) which has a first opening (27) for admitting an emulsion (14') of waste water (8, 9) and fat (14), a second opening (28) for adding organic waste (16), and a circulating element (29) situated in the chamber (26) for circulating a mixture (14', 16) of the added emulsion (14') and the added organic waste (16), and comprising a heating element (30) for drying the mixture (14', 16) by evaporating water (31) out of the mixture (14', 16).
