Abstract (en)  
[origin: WO2022036530A1] Device for packaging and dispensing a cosmetic product comprises a bottle and a at least one cartridge. The device (10) for packaging and dispensing a cosmetic product prepared by mixing a first and a second bulk comprises: a bottle (12) defining a bottle reservoir (28) containing the first bulk; a cartridge (14) defining a cartridge reservoir (102) containing the second bulk and comprising a seal (76), the cartridge (14) being arranged between a disassembled configuration and a mounted configuration; a seal opening mechanism (18) adapted to open the seal (76) in the mounted configuration, the bottle reservoir (28) and the cartridge reservoir (102) being in fluid communication in the mounted configuration; and a dispensing apparatus (16). The cartridge (14) comprises a removable cartridge-sealing plug (62) designed to cover the seal (76) in the disassembled configuration and being replaced with the bottle (12) in the mounted configuration.
